IPR protection provides a tool for entrepreneurs to appropriate their returns from innovation by protecting and commercializing their IPRs. The programme primarily focuses on the importance of innovation and implication of IPR in promoting entrepreneurship and start-up ecosystem among research scholars, young innovators and academicians. We aim at creating awareness among entrepreneurs to monetize their innovation by protecting and commercializing through IP.

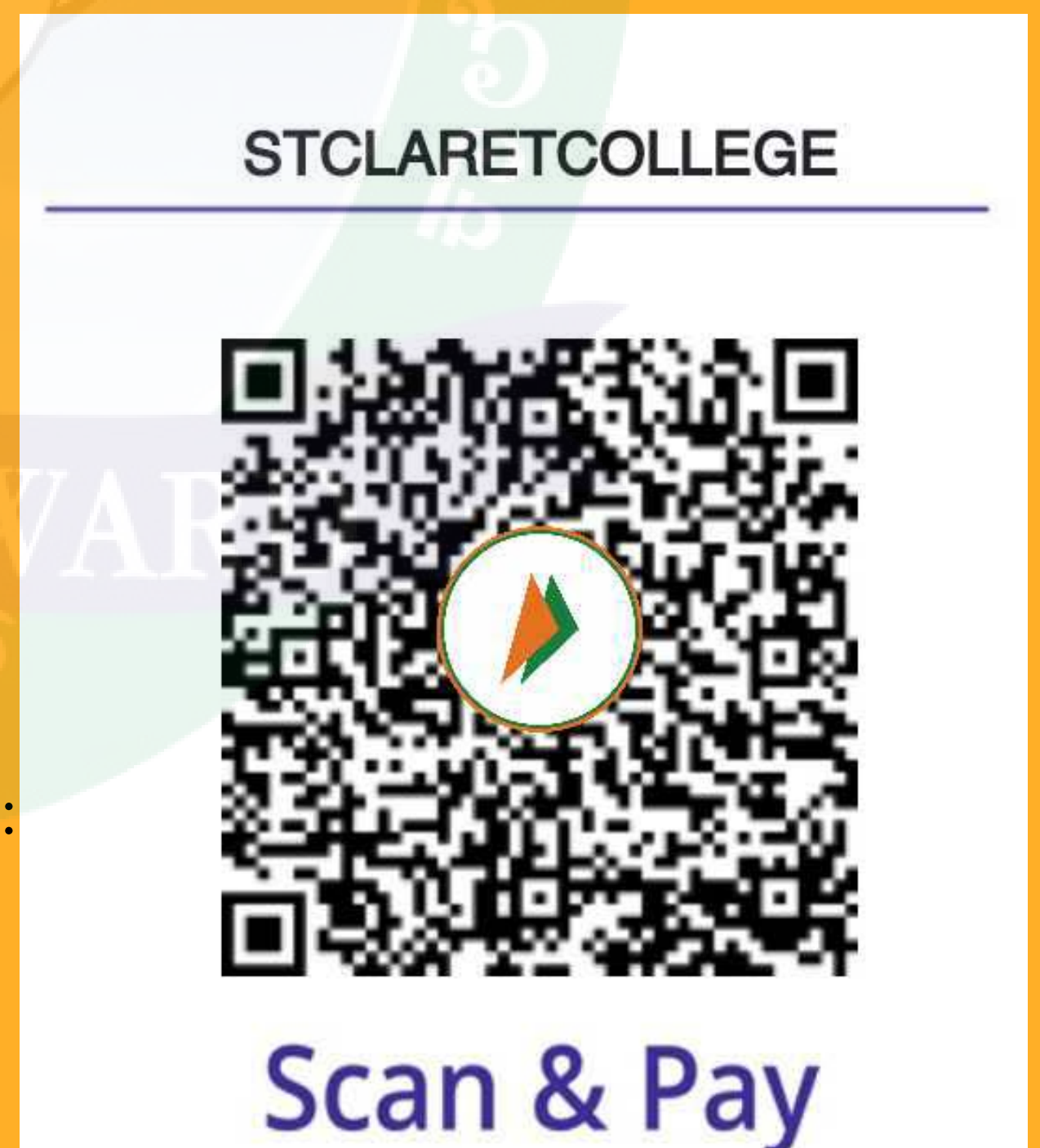


## *Instructions for Participants*
